

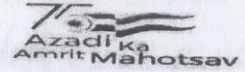

ORDER

In exercise of the powers conferred by Section 22 of the Central Administrative Tribunal Act, 1985 (Central Act 13 of 1985), the Central Administrative Tribunal makes the following amendment in Rule (4) of the Central Administrative Tribunal Rules of Practice, 1993.


CHAPTER III

*PREPARATION AND PRESENTATION OF PLEADINGS
AND OTHER PAPERS*

4. Preparation of pleadings and other papers:-

- (a) All pleadings, affidavits, memoranda and other papers filed in the Tribunal shall be fairly and legibly typewritten or printed on durable white paper of A4 size (29.7 cm X 21 cm) having not less than 75 GSM with font – Times New Roman, font size 14, in 1.5 line spacing (for quotations and indents – font size 12 in single line spacing), with margin of 4 cm on left & right and 2 cm on top & bottom duly paginated, indexed and stitched together in the paper-book form. The index shall be in Form No. 1. The printing/typing shall be on both sides of the paper.

These amendments shall come into force with effect from 01.12.2022.
